Children's Cassocks, Albs and Tunics

The measurements required to supply any of the above would be the chest and height. The chart illustrates the garment length based on the height allowing the garment to be worn the traditional 3 inches from the ground. Children's sizes for zero rated value added tax (VAT) purposes are limited to a maximum of 33" chest and a length of 52", if either of these measurements are exceeded tax has to be added. The chart below illustrates the zero rated size range.
